

PROMOTION TERMS AND CONDITIONS

THESE ARE THE OFFICIAL PROMOTION TERMS AND CONDITIONS. PARTICIPATION IN THE PROMOTION CONSTITUTES ACCEPTANCE OF THESE PROMOTION TERMS AND CONDITIONS (THE “PROMOTION TERMS”).

Definitions:

Participating Facilities: Chances Squamish

Promotion: This is a promotion in which Encore member slot players who are Qualified Entrants will receive a ballot with no purchase necessary in order to enter a Draw at any given Draw Time in order to win bonus play prizes and/or a merchandise Draw Prize. See the “How to Enter the Promotion” Section below for more details.

Promotion Period: August 30, 2026 at 10AM PT to October 31, 2026 at 6:59PM PT

Draw Days: Saturdays, September 5, 12, 19, 26 and October 3, 10, 17, 24, 2026.

Draw Times: 7PM PT on each Draw Date

Draw Prize(s): A total of eight (8) bonus play prizes of three hundred dollars (\$300) will be available to be won for a combined total of two thousand, four hundred Dollars (\$2,400) bonus play. (SQG-SAT\$300)

Grand Prize Draw Days: Saturday, October 31, 2026

Grand Prize Draw Times: 7PM PT

Grand Prize Draw Prize(s): A total of one (1) merchandise prize per Drawn Entrant available to be won. The prizes are: one (1) 55’ Hisense TV with the approximate value of \$500 CAD.
Plus, one (1) bonus play prize of three hundred dollars (\$300). (SQG-SAT\$300)

Draw: A draw for a Draw Prize at each Draw Time.

Gaming Day: The 24-hour period from 7:00am PT on one day to 6:59am PT the following day during the Promotion Period.

- Qualified Entrant:** An individual who is 19 years of age or older and either a Canadian or American resident, but does not include
- Employees, agents, successors and assignees of Gateway, its advertising agencies and promotional companies involved in this Promotion (if any), as well as family and household members of the same who reside at the same address;
 - Employees, agent's successor and assignees of BCLC or the participating gaming service provider and their family and household members who reside at the same address;
 - Individuals who have self-excluded or who self-exclude during the Promotion Period and individuals that are barred from a BCLC gaming facility; and
 - Residents of New York, Rhode Island, Florida or Texas U.S.A

Winner's Authorization Form: Such representations, indemnities and releases as Gateway may require in its sole discretion from a Drawn Entrant in consideration of and in order to induce Gateway to deliver a Draw Prize to the Drawn Entrant.

How to Enter the Promotion:

1. Encore membership is required.
2. **No Purchase Necessary Entry Method:** All Qualified Entrants may receive one (1) complimentary daily by visiting the cash cage. (**SQG-BALLOT1**) (no purchase/play necessary).
3. Qualified Entrants may receive one (1) ballot per every hand paid jackpot during the Promotion Period.
4. Qualified Entrants must complete the ballot in full and deposit ballot in the Draw Barrel prior to draw time in order to qualify.
5. The Draw Barrel will be closed two (2) minutes prior to each Draw Time.
6. Qualified Entrants must be present at the Draw Time to win.

How to Win a Draw Prize:

1. Odds of winning a Draw Prize are based on the total number of entry ballots in the draw barrel at draw time.
2. Under surveillance at the Participating Facility, two (2) IGCO registered employees will conduct each Draw at the Draw Barrel to select one Drawn Entrant. The Drawn Entrant must be present to win. Drawn Entrants will have one (1) minute to present themselves at the Draw area to have the opportunity to claim their prize.
3. If a Drawn Entrant is not present, another draw will be conducted until a winner is present. This process will continue until a winner is declared.
4. Draw Barrel will be emptied after each Draw during the Promotional Period.
5. These ballots will go into the Grand Finale Draw Barrel.

6. A Drawn Entrant will be required to present valid government issued photo identification, prior to proceeding further with the Draw Procedure.
7. A Drawn Entrant must complete a Winner's Authorization Form in the presence of two (2) registered gaming employees, before the Draw Prize can be released.
8. The winning entry will be checked against the Voluntary Self-Excluded and Barred lists. If the winner's name appears on any of these lists, the entry will be disqualified and another entry will be drawn.
9. Gateway's Surveillance Department will record each Draw and will hold the footage in its entirety for thirty (30) days.
10. Each Qualified Entrant may win more than one (1) Draw Prize per Promotion but not more than one (1) Draw Prize per Draw Day.

How to Win a Grand Prize Finale Draw Prize:

1. Odds of winning a Draw Prize are based on the total number of entry ballots in the draw barrel at draw time.
2. Under surveillance at the Participating Facility, two (2) IGCO registered employees will conduct each Draw at the Draw Barrel to select one Drawn Entrant. The Drawn Entrant must be present to win. Drawn Entrants will have one (1) minute to present themselves at the Draw area to have the opportunity to claim their prize.
3. If a Drawn Entrant is not present, another draw will be conducted until a winner is present. This process will continue until a winner is declared.
4. The Grand Finale Draw Barrel will contain all of the ballots from the whole promotion. The ballots will be emptied after this draw.
5. A Drawn Entrant will be required to present valid government issued photo identification, prior to proceeding further with the Draw Procedure.
6. A Drawn Entrant must complete a Winner's Authorization Form in the presence of two (2) registered gaming employees, before the Draw Prize can be released.
