

## **PROMOTION TERMS AND CONDITIONS**

**THESE ARE THE OFFICIAL PROMOTION TERMS AND CONDITIONS. PARTICIPATION IN THE PROMOTION CONSTITUTES ACCEPTANCE OF THESE PROMOTION TERMS AND CONDITIONS (THE "PROMOTION TERMS").**

### **Definitions:**

**Participating Facilities:** Chances Squamish

**Promotion:** Penny Power Sundays is a promotion in which Qualified Entrants can automatically trigger the Spin 2 Win bonus game by inserting their Encore Rewards card into any penny slot machine and meeting the Wagering Requirement at a Participating Facility during the Promotion Period. See the "How to Enter the Promotion" Section below for more details.

**Promotion Period:** Sundays at 12:00 PM PT to Sundays at 8:00 PM PT

**Promotion Days:** Sundays - Ongoing

**Promotion Time:** 12:00 PM PT to 8:00 PM PT on each Promotion Day.

**Prize(s):** Qualified Entrant may win a maximum of one (1) Prize on each Promotion Day during the Promotional Period. The maximum total prize value available to be won by a Qualified Entrant on each Promotion Day is one thousand five hundred Canadian dollars (CDN \$1,500), awarded as 300,000 Encore Rewards points.

A Qualified Entrant will win a Prize in the amount associated with the segment where the wheel stops, as described in Appendix 1.

**Wagering Requirement:** Qualified Entrant must wager three hundred Canadian Dollars (\$300 CDN) on any penny slot machine at a Participating Facility, exclusive of any Bonus Play credit.

- BCLC:** British Columbia Lottery Corporation
- Gateway:** Gateway Casinos & Entertainment Limited
- Gaming Day:** The 24-hour period from 7:00am PT on one day to 6:59am PT the following day during the Promotion Period.
- Qualified Entrant:** An individual who is 19 years of age or older and a valid Encore Rewards member and either a Canadian or American resident, but does not include:
- Employees, agents, successors and assignees of Gateway, its advertising agencies and promotional companies involved in this Promotion (if any), as well as family and household members of the same who reside at the same address;
  - Employees, agent's successor and assignees of BCLC or the participating gaming service provider and their family and household members who reside at the same address;
  - Individuals who have self-excluded or who self-exclude during the Promotion Period and individuals that are barred from a BCLC gaming facility; or
  - Residents of New York, Rhode Island, Florida or Texas U.S.A.

**How to Enter and Win a Prize:**

1. Encore membership is required.
2. Odds of winning a Prize is 100% once wagering requirement has been met.
3. A Qualified Entrant automatically triggers the Spin 2 Win bonus game by meeting the Wagering Requirement of three hundred Canadian Dollars (\$300 CDN) on any penny slot machine at a Participating Facility on Promotion Day during the Promotion Period. The Wagering Requirement must be satisfied on each Promotion Day between 12:00 PM and 8:00 PM PT during the Promotion Period.
4. Once a Qualified Entrant meets the Wagering Requirement during the Promotion Time, the Spin 2 Win bonus game will automatically launch. The game consists of a 20-position interactive prize wheel displayed on-screen. Each wheel segment contains a prize value that is awarded to the Qualified Entrant when the wheel stops on that segment.
5. The Prize will be credited to the Qualified Entrant's Encore Rewards account after completing the Spin 2 Win game.
6. Each Qualified Entrant may win more than one (1) Prize during Promotion Period but only one (1) Prize on each Promotion Day at the Participating Site.

**How to Claim the Prize:**

1. The Prize awarded must be redeemed by completing one of the following Points redemptions processes:
  - a. **E-Table Redemption Process** Qualified Entrant inserts their Encore Rewards Card or enters the phone number and PIN associated with their Encore Rewards account into any e-Table machine at any Participating Facility with their PIN to redeem the Points as Prize;
  - b. **Slot Prize Redemption Process:** Qualified Entrant inserts their Encore Rewards Card or enters the phone number and PIN associated with their Encore Rewards account into any slot machine at any Participating Facility with their PIN to redeem the Points as Prize.
2. The Qualified Entrant must redeem the Prize at any Participating Facility or online within 365 days from the date it is awarded. An expired Prize will not be reactivated.

**General Conditions:**

1. Encore Rewards membership is required.
2. All winners must correctly answer the mathematical skill-testing question outlined below before any prize is awarded:

5. Gateway may, at their sole discretion and without liability to any person, alter, amend, suspend or cancel the Promotion and/or the Promotion Terms at any time and for any reason without prior notice.
6. Gateway shall have the right to publish the name, location and a recent photograph of the winner(s) without remuneration to them.
7. Gateway reserves the right to not award any prize, in the event that the integrity of all or part of the Promotion is compromised (including, but not limited to, due to computer error, fraud, deception, misrepresentation or misuse).
8. Gateway makes no representations or warranties whatsoever, either expressed or implied, oral or written, in respect to any prize.
9. Gateway is not responsible for any typographical errors in the administration of the Promotion and/or in any promotion related materials.

10. All prizes must be accepted as awarded and are non-transferable. The refusal by a Qualified Entrant to accept any prize releases and forever discharges Gateway from all obligations to that Qualified Entrant in connection with the Promotion, including delivery of any prize.
11. Gateway reserves the right to substitute any prize or portion thereof with one of equal or greater value.
12. All Gateway decisions in relation to the Promotion are final and binding.

Personal information is collected in accordance with the *Freedom of Information and Protection of Privacy Act* (British Columbia) and will be used, accessed, disclosed and stored by Gateway only for the administration of the Promotion. By participating in the Promotion, each Qualified Entrant: (i) grants to Gateway the right to use his/her name, mailing address, telephone number and e-mail address ("**Personal Information**") for the purpose of administering the Promotion, including but not limited to contacting and announcing the winner; (ii) grants to Gateway the right to use his/her Personal Information for publicity and promotional purposes relating to the Promotion in any and all media without further compensation unless prohibited by law; and (iii) acknowledges that Gateway may disclose his/her Personal Information to BCLC and Gateway's third-party agents and service providers in connection with any of the aforementioned purposes.   - a. release and discharge, and agree to indemnify, save and hold harmless Gateway and its directors, officers, employees, affiliates, agents and representatives from any and all liabilities, claims, damages, demands, actions or causes of action whatsoever which they or their heirs, successors, assigns, executors or administrators may now or hereafter have directly or indirectly against them or any of them in respect or relating to the Promotion, the Qualified Entrants' participation in the Promotion and/or the acceptance or use, misuse or possession of any prize and travel related thereto; and
  - b. release and discharge, and agree to indemnify, save and hold harmless BCLC and its directors, officers, employees, affiliates, agents, and representatives (the "**Releasees**") from and against any and all actions, claims or demands (including costs incurred by BCLC in defending such actions, claims or demands) which they may now or hereafter have against the Releasees, or any of them, arising directly or indirectly out of, or which are in any way connected to, this Promotion.
